Selected Bidder Notice

Dear Mr. Hamzeh,

On 27 April, 2016, the Ministry of Transport and Infrastructure of the Republic of Albania (MTI) issued a Request for Proposals (RfP) with the objective to award a concession to upgrade, operate and maintain the Milot – Morine Highway (the "Project").

On 30 May, 2016, the Bid Evaluation Commission appointed by the MTI opened the bids submitted for the Project.

The following Prospective Bidders participated in the tender by offering respectively:

A Consortium comprised of CATALYST VIVA DAS GENERAL CONTRACTING LLC (U.A.E.) – SALILLARI LTD (Albania) – BEE TECH (Greece) – VIOLIAP ATEVE (Greece) – KASTRATI S.A. (Albania) (the "Catalyst Consortium") submitted a bid for the Project prior to the Submission Deadline referred to in Clause 2.2.1 of the RfP in the amount of 4,995,000 Euro (four million nine hundred ninety five thousand Euro).

A Consortium comprised of VENDEKA (Turkey) – CITRA (Indonesia) – MAU (Turkey) – SAVRONIK (Turkey) – VENDEKA EUROPEAN (Turkey) (the "Vendeka Consortium") submitted a bid for the Project prior to the Submission

Deadline referred to in Clause 2.2.1 of the RfP in the amount of 5,600,000 Euro (five million six hundred thousand Euro).

On August 29, 2016, the Public Procurement Commission ruled to disqualify the Vendeka Consortium and to prequalify the Catalyst Consortium and designate it as Preferred Bidder.

Referring to the abovementioned procedure, the Ministry of Transport and Infrastructure of the Republic of Albania notifies the Catalyst Consortium that the Bid submitted on 30 May, 2016, in respect of the Milot – Morine Highway PPP Project has been accepted.

Within 7 days from the date of this Selected Bidder Notice, the Catalyst Consortium shall submit to MTI an acknowledgement of the Selected Bidder Notice, agreeing to comply with the conditions set out therein and to execute the concession agreement.

In the event that the Catalyst Consortium does not wish to sign the concession agreement, you shall notify MTI in writing.

Notwithstanding the provisions of Clause 11 of the RfP, failure by the Catalyst Consortium to:

- within 7 days of this Selected Bidder Notice, send the acknowledgement agreeing to comply with the conditions set out therein and execute the concession agreement, or
- within 30 days of this Selected Bidder Notice, pay to MTI fees in the amount of 20,000 EUR as set out in Clause 6.2 of the RfP, or
- within 60 days of this Selected Bidder Notice, execute the concession agreement subject to the provisions of Clause 19.3 of the RfP, or
- within 5 days of executing the concession agreement, submit the Contract Security in accordance with the requirements set out in Clauses 2.4-2.6 of the concession agreement

shall constitute sufficient grounds for the annulment of this Selected Bidder Notice and forfeiture of the Bid Guarantee issued by the Catalyst Consortium.
